A DANGEROUS SPIRAL

A legal arms race of uncoordinated, reactive, quick-fix and potentially incompatible public and private policy initiatives:

- Creates **competing assertions of jurisdiction** where compliance with one state's law can result in a direct violation of other states' laws;
- Actually prevents actors from efficiently addressing abuses online;
- Hampers digital innovation and growth of the internet economy, especially in developing countries and for SMEs;
- Favors the **rule of the strongest**.

Due to the norm setting process, and extraterritorial assertions of jurisdiction, in some regions, individuals, organizations and even states feel **subjected to online rules developed without them** in a country far away.

Provides an indispensable mapping and analysis of the regional ecosystem


Set up and strengthening of a **Regional Contributors Network**

Coordination is key to a LAC digital single market. Priority areas: Consumer and data protection, digital payments and tax regimes. **Corruption scandals** have fostered regional cooperation among law enforcement.

This has created the conditions for the standardization of cross-border data transfers in the region.
